

Declaration Of Jason Fishbein

3 I, Jason Fishbein, declare as follows:

4 I have personal knowledge of the facts stated below and they are true. Where facts are
5 stated on information and belief, I believe them to be true. If called upon to testify, I
6 would and could competently testify thereto. I offer this declaration in lieu of live
7 testimony.

9 1. My name is Jason Fishbein. I am a Licensed Private Investigator, and I regularly
10 work on cases involving divorce proceedings. Further, I know Ms. Perrett and Mr.
11 Shivers personally.

13 2. I have witnessed Ms. Perrett posting messages about an enemy of hers on the
14 internet, and I have witnessed her using a false name to do so, in order to avoid
15 detection.

17 3. I have witnessed Ms. Perrett's representation of various facts as she told to me in
18 the past, which do not match the way she has represented those same things to the
19 court during her divorce proceedings.

21 4. One example would be that she described to me how Mr. Shivers' income was used
22 to pay the mortgage on the Whitley Terrace home, and specifically that it was in cash
23 because of his work in nightclubs. It is my understanding that Ms. Perrett completely
24 lied to the court many times about this fact. For this reason it is my professional opinion
25 that her credibility is questionable.

2 5. As another example, Ms. Perrett told me about her fondness for Restraining Orders,
3 and that it was she who insisted that Mr. Shivers get one against Beverle "Bebe" Buell.
4 Those were Ms. Perrett's words: that Mr. Shivers was "reluctant" and that eventually
5 she "insisted." I understand that Ms. Perrett has told an opposite version of events to
6 the court and I state firmly that her story now is the exact opposite of what she told me.

8 6. Ms. Perrett also proudly told me she had a Restraining Order against another
9 boyfriend of hers named Daniel Rivas, who she called "Danny." I have recently been
10 informed that she was lying about that Restraining Order. I have no idea why Ms.
11 Perrett would make such slanderous and defamatory statements about Mr. Rivas.

13 7. Ms. Perrett also told me she broke up with Danny after she caught him having sex
14 with his sister (Sarah Rivas). I recently was told this was also untrue. Again, I do not
15 know why Ms. Perrett would make such defamatory statements.


17 8. Based on what I witnessed, it is my educated professional opinion that Ms. Perrett is
18 not credible, is vindictive when she breaks up with someone, and she described herself
19 as a "serial monogamist killer", that she "plays the victim" in order to further her means,
20 and that she possibly uses Restraining Orders as a method of harassment.

22 9. Based on many discussions with Mr. Shivers, and Ms. Perrett, and Ms. Perrett's
23 friend Mathew Sandusky, it is also my opinion that Mr. Shivers' story has remained
24 virtually the same over the years, while Ms. Perrett's story seems to have changed
25 considerably, apparently to suit her needs.
