GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:

On Wednesday January 23, 2019 the complainant, hereafter referred to as C-1, called the sexual assault unit office and stated a female, hereafter referred to as the defendant or D-1, grabbed his penis a few days ago and that there was video of the offense.

Your affiant, Detective Jordan Katz, contacted and interviewed C-1. C-1 said he was in Washington, DC on Saturday January 19, 2019 and this occurred at the "Women's March" at about 1230-1330 hours. C-1 said he didn't know the exact intersection where this occurred, but he knew it was a few blocks away from New York Avenue and 14th Street and near the main stage of the "Women's March." C-1 said D-1 was named "Isabel O'Shaughnessy" and she walked up to him in the middle of the street. D-1 grabbed and squeezed C-1's genitals in public and C-1 said he had the whole thing on video and that D-1 also gave a "verbal admission."

Detective Katz asked C-1 for the context of what exactly happened. C-1 said he was a reporter and standing there and the whole entire event was on video. C-1 was interviewing another individual who he was speaking back and forth with. D-1 came up from behind him, "out of nowhere," and grabbed C-1's genitals and squeezed them. D-1 then laughed about this and C-1 told Detective Katz that D-1 got the whole crowd cheering about it. C-1 said he worked for InfoWars and he confirmed that D-1 grabbed his penis.

Detective Katz asked C-1 how he knew D-1's name was "Isabel O'Shaughnessy." C-1 said he had D-1 identified via the video and tipsters who knew her contacted C-1. Detective Katz asked C-1 if he put this video somewhere. C-1 said the video can be found on his "Twitter" account which was "@alldoisowen." C-1 said he didn't know how old D-1 was but that she was under or around thirty and a white female.

C-1 later e-mailed Detective Katz the link to his "Twitter" page and digital conversations with the tipsters and photographs of the woman he believed to be D-1. Detective Katz reviewed C-1's "Twitter" page. On January 19, 2019 C-1 posted, "A #womensmarch protestor walked up to me and

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:									

literally grabbed my dick. Handful, Squeeze. These are truly sick and demented people. Videos coming." On January 19, 2019 C-1 also posted, "Already receiving feedback on our coverage of the #WomensMarch2019. 80% of our content from today is unaired. The vile and disgust of these people you have barely seen. Videos coming."

On January 21, 2019 C-1 posted a video of the event. C-1 posted the following caption above the video, "Here is the moment I was sexually assaulted by a #WomensMarch2019 protester. She laughed about it. The crowd cheered it. The police did nothing."

Detective Katz reviewed the twenty-six second video posted on C-1's "Twitter" account. In the video, C-1 was wearing a red "Make America Great Again" baseball hat, a suit and tie and a Trump 2016 scarf. C-1 was holding a microphone and interviewing a male who wore glasses. While interviewing this male, the camera pans or skips back and D-1 approached C-1 from his left side. D-1's left shoulder appeared to drop downward, in front of C-1, and her left hand and most of her arm was out of view from the camera.

C-1 immediately moved his hips backward and away from D-1. D-1 stated, "So if our president can grab a woman by the pussy, I can grab you by the balls." C-1 then turned to his right and stated, "She just grabbed my dick, is that sexual assault?" C-1 then asked D-1, "Is that sexual assault?" and C-1 held the microphone toward D-1. D-1 replied "Yes." C-1 then said, "So you just sexually assaulted me?" D-1 replied, "I did assault you." C-1 said, "Should you be arrested" and D-1 replied, "Arrest me" and C-1 said, "I'm not gonna arrest you." D-1 said, "There are police officers right here, but." C-1 then said out loud to the crowd, "So look at this, women have so much privilege she can sexually assault me and get away with it. If I did that to her I'd get arrested." The video posted to "Twitter" then ended.

On January 24, 2019 additional video footage, which encompassed the entire event, was posted to "YouTube" by a co-worker of C-1. The video

GIVE A BRIEF DESCRIPTION OF WHAT HAPPENED:																									

begins with C-1 starting to interview the previously mentioned white male who was wearing glasses. At the start of the video, D-1 can be seen behind C-1 in the crowd. C-1 and the male begin to speak about Hilary Clinton and the election. C-1 explained to the male that he was out there because all of the women and all of the people marching are trained by the propaganda and the mainstream news. C-1 said they (the marchers) believing that women are oppressed in America "is a fricking joke." C-1 said women in American are more empowered than women in any other country on earth.

C-1 and the male debate this topic and the male explains his point. C-1 said he thinks these people are all marching because they "hate Trump" and the media got them all "drummed up to hate Trump." C-1 said he didn't think any of these people would be marching if Trump wasn't president. The male said he thinks this (the march) was necessary for the rhetoric that Donald Trump uses against women. The male explained to C-1 that he thinks "grab them by the pussy was a huge thing" and that that was a horrible statement. C-1 said Trump was having a conversation and talking and C-1 said that he doesn't endorse the statement but that it was a "minor issue." In the video, someone in the crowd, who sounded like a female, can be heard saying "a minor issue." D-1 then approached C-1 and the video now coincides with what was originally posted to C-1's "Twitter" page."

After D-1's actions and C-1's comment that he would get arrested if he did that to D-1 (which was where the original "Twitter" video ended), D-1 replied, "I just told you, if you want to go ahead there are police right here." C-1 replied, "I'm not complaining. You're the one that walked up and grabbed my crotch." D-1 replied, "Yea, because I'm fighting for equality here." C-1 asked her, "How so?" D-1 replied, "Women get grabbed by the fucking pussy, then I'm gonna grab you by the balls. You're out here spewing bullshit." D-1 added that C-1 was out there provoking people and then D-1 walked away and the encounter ended.

In regards to D-1's identity, two tipsters later contacted C-1 with information about D-1. The contacts with C-1 occurred after the video was posted on his "Twitter" page. C-1 provided Detective Katz with a digital conversation chain with one of the tipsters. In the chain, the tipster sent C-1 a "Tweet" photograph, from 2018, which featured DC Mayor Muriel Bowser along with D-1 and others. C-1 replied to the photographs, "Appears so Can't say

for sure." This tipster then wrote, "It lines up as she's DC activist and that twitter account is DC activism." C-1 told this tipster that someone else believed her name was "Isabel O'Shaughnessy" and the tipster wrote back, "Yes that is the name I was given All of she spxial media accounts have been deleted."

C-1 provided Detective Katz a text chain with the other tipster. In the chain, the tipster wrote, "I go to school in DC and am almost positive this girl goes to my school I don't want a case of misidentification but the girl I am thinking of is Isabel oshaughnessy." C-1 texted the tipster, "Do you have pictures of her?" The tipster replied, "She goes to the catholic University of America" C-1 then texted this tipster a photograph of D-1 with Muriel Bowser (which was provided to him by the other tipster) and this tipster replied, "Definitely her Those are her friends from school"

C-1 confirmed that ultimately a tipster sent him a photograph of D-1 and C-1 confirmed this was the same person who assaulted him.

Detective Katz searched "Google" for "Isabel O'Shaughnessy" and noticed that "Isabel_osh" on Instagram was not available nor were the "Facebook" and "Linked" pages for this name.

On January 24, 2019 Detective Katz interviewed W-1. W-1 stated that "IT" was a co-worker of C-1 at "InfoWars." W-1 said they were all at the "Women's March" and they were there interviewing people and W-1 was there with "IT's" camera and standing off to the side. W-1 said "IT" was getting shots of everything that was going on and the women and the signs and C-1 was interviewing people. D-1 then came up to C-1 and "I guess to prove a point" D-1 grabbed his "genitalia." W-1 said there were a couple of police officers surrounding them and the police didn't have any reaction to it. C-1 asked D-1 if that was sexual assault and D-1 immediately said that yes it was. W-1 said they didn't speak to the police but that they were right

Detective Katz asked W-1 if "IT" filmed the video on "Twitter" or if "IT" was filming something else. Detective Katz showed W-2 a screenshot of D-1 (from C-1's "Twitter" page) at the march and W-2 nodded his head up and down. Detective Katz asked W-2 if that was "Isabel O'Shaughnessy" and W-2 said "IT" didn't "want to."

Detective Katz told D-1 he wanted to "nip this in the bud" before it escalated and to speak with D-1 about it. D-1 said "okay" and then asked, "Do I need a lawyer?"
